

Biography for Stacy Turner

Stacy Turner is the founder and principal attorney of The Turner Law Offices, a boutique estate planning, elder law, and special needs law practice serving clients throughout the San Francisco Bay Area. Since beginning her legal career in 2005, Stacy has focused exclusively on estate planning, estate administration, probate, and special needs law—practice areas that allow her to build long-term relationships with families and make a lasting difference in the lives of her clients.

Stacy's practice encompasses three interconnected areas of law. First, she works with individuals and families to design comprehensive estate plans tailored to their unique circumstances—from young couples just beginning their families to retired couples, small business owners, professionals, and parents planning for children with disabilities. This holistic, person-centered approach ensures that estate plans are not merely technical documents, but living frameworks that preserve family relationships and reflect what matters most to each client.

Stacy received her bachelor's degree in political science from the University of Wisconsin-Madison and her law degree from the University of California College of the Law, San Francisco (formerly UC Hastings College of the Law). She opened her own practice, The Turner Law Offices, in August 2009, and has practiced as a solo practitioner ever since.
